

Context Statement

Roseworthy Primary School caters for students from R-6. At the time of this report, the enrolment in 2024 is 174. Roseworthy Primary School is classified as Category 7 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 6% Aboriginal students, 9% students with disabilities, 3% children/young people in care. Governing Council Report

I want to take a moment to express my gratitude to our current & outgoing Governing Council for their dedicated time and support over the past year. Your commitment to our school has made a significant impact, and we deeply appreciate all the hard work you have contributed. Last year, our Governing Council consisted of eight parents, one community member, one principal, and one teacher.

This year has been highlighted by several achievements, including successful fundraising initiatives that have enabled us to enhance our facilities and resources. We are excited about our ongoing projects, which aim to further improve our school environment and enhance learning outcomes for our students. The following developments have been made: creation of a new grassed area, completion of the outdoor education area, acquisition of a 3D printer, purchase of coding balls, installation of microphones in three classrooms, with one upgrade made possible through our fundraising efforts. Significant upgrades to the school included:

- Room 8: new flooring, painting, and cabinetry
- Room 9: new flooring
- Installation of new lighting throughout the campus
- Removal of trees deemed unsafe by an arborist with plans for replacements in the future
- Completion of the outdoor education area including planter boxes and tables

This year, we have also focused on engaging the wider community through various initiatives, including: Colour Fun Run, Start Right Night, Coffee Chat Mornings, Sports Days, Concerts, School Community Facebook Page, Year 6 Graduation, Working Bees, Multiple Sports Carnivals. These initiatives have fostered a stronger connection between our school and families, providing valuable opportunities for collaboration and support. We welcome your feedback and input on council activities.

Your perspectives are vital in our decision-making processes, and we encourage you to share your thoughts with us.



NAPLAN Proficiency









Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or nongovernment school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
